ORDER:-

In the G.O. 10th read above, revised guidelines were issued in respect of eligibility criteria with regard to selection of beneficiaries under Deepam scheme.

In the G.O. 11th read above, Government have constituted Gram Panchyat / Mandal / Municipality committees to conduct verification of existing pensions and collection and finalization of the new pension applications. To bring uniformity, it is decided that beneficiaries under Deepam scheme shall also be identified by these Janmabhoomi Committees for selection of LPG Deepam beneficiaries.
